It is submitted that the above mentioned Special Leave Petition is filed by Mr. Jagjit Singh Chhabra, Advocate on 26.06.2014 against the Judgment and Order dated 25.07.2013 of the High Court of Punjab and Haryana at Chandigarh in CWP No. 15945 of 2013 barred by time by 246 days along with the applications for condonation of delay in filing SLP, permission to place on record additional facts and documents and permission for urging additional grounds.

It is further submitted that SLP (C) No.23578 of 2012 @ CC No.17901 of 2011 Entitled State of Punjab & Ors. It is further submitted that notice in RP No. 2038 of 2013 in SLP (C) No. 23578 of 2012 Entitled State of Punjab & ors. Versus Harbans Lal was directed on 31.10.2013 by Hon'ble Mr. Justice H.L. Dattu and Hon'ble Mr. Justice J. Chelameswar. Review Petition is pending after notice (Copy of order dated 31.10.2013 is annexed as Annexure P-10 at page no.81 in the paper books).

It is further submitted that notice in SLP (C) No. 9838 of 2014 @ CC No. 5453 of 2014 Entitled State of Punjab & Ors. Versus Mahinder Singh & Ors. arising out of similar issue was directed on 04.04.2014 by Hon'ble Dr. Justice B.S. Chauhan and Hon'ble Mr. Justice J. Chelameswar. SLP is pending. Copy of order dated 04.04.2014 is enclosed herewith).

The matter is listed before the Hon'ble Court with this office report.
