4770, 16336, 8324, 14035, 21459 and 491 of 2014

Service upon the sole respondent in SLP(C) No. 3513 of 2014,
SLP(C) No. 4769 of 2014 and SLP(C) No. 11957 of 2014 is complete.

Three of these petitions now fall in the complete category.

The sole respondent of SLP(C) No. 18544 of 2014 and all 17
respondents in SLP(C) No. 8427 of 2014 have filed the counter
affidavit. These two petitions also fall in the complete category.

Opportunity to file counter affidavit for all 15 respondents
in SLP(C) No. 3409 of 2014, of all 29 respondents in SLP(C) No. 336
of 2014, of all 42 respondents in SLP(C) No. 3512 of 2014 and of
all 47 respondents in SLP(C) No. 4770 of 2014 has already been

SLP(C) No. 36645 of 2013
