SLP (C) Nos. 36645, 36646 OF 2013, 336, 491, 3408, 3409, 3411, 3511, 3512, 3513, 4769, 4770, 4771, 5788, 16336, 17267, 21459, 18544, 14035, 8324, 8386, 8427, 8428, 9830, 9831, 9832, 9833, 9836, 9838, 9839 & 9842 of 2014

The matters above mentioned except were listed before the Ld. Registrar's Court on 31.03.2015, when the following order was passed:-

" Learned Counsel of respondent nos.1-5,7,9-13 in SLP(C)36645/ 2013 and respondent nos. 45, 52, 53 in SLP(C)36646/2013 to cure the defects in Vakalatnama. Be cured within two weeks and counter affidavit be filed within four weeks thereafter.

Service in respect of respondent nos. 6 and 8 in SLP(C)36645/2013 and for respondent nos. 1-44, 46-51 and 54-63 is complete but none has entered appearance.

Ld. Counsel of respondent nos. 1-16 in SLP(C)3408/2014 and respondent nos. 11-25 in SLP(C)4771/2014 to cure the defects in the vakalatnama. Be cured within two weeks and counter affidavit be filed within four weeks thereafter.

Respondent no.9 in SLP(C)4771/2014 has expired. One more application is given to file an application for substitution.

Ld. Counsel for the petitioner to serve the copy of Special Leave Petition to the respondent nos. 1, and 2 in SLP(C)491/2014 and proof thereof be filed within two weeks. However, counter affidavit to be filed within four weeks.

Service is awaited in respect of respondent nos.10,21-29 in SLP(C)3411/2014,respondent no. 41 in SLP(C)3511/2014 and for all 29 respondents in SLP(C)3513/2014.

Learned appearing Counsel in SLP(C)Nos. 3409, 3411,336,3511,3512,3513,4769,4770 have not filed counter affidavit despite last opportunity given. Further opportunity is declined.

SLP(C) No. 17267/2014:

Ld. Counsel for the petitioner to take fresh steps to serve the unserved respondent nos.1,4,28-31 within four weeks.

Service on respondent nos.2,3,5-27, 32-42 is complete but no one has entered appearance.

SLP(C) No. 21459/2014:

Ld. Counsel for the petitioner to take fresh steps to serve all the unserved respondents within four weeks.

SLP(C) No.16336,18544,14035/2014:

Ld. Counsel for the petitioners to take fresh steps to serve the unserved sole respondent within four weeks.

SLP(C)No.8324,8326,8427,8428,9830,9831,9832,9833,9836,9838,9839 and 9842/2014:

Learned counsel for the petitioners to take fresh steps to serve the unserved respondents in all the above mentioned matters within four weeks.

Registry to report for filing of counter affidavit by the appearing counsel in all the matters.

* In SLP (C) No. 3408/14, Ms. Sunita Sharma, Advocate for Respondent Nos. 1-16 has not cured the defects in the Vakalatnama /Memo of Appearance and has not filed Counter Affidavit on their behalf.

** In SLP (C) No. 3411/2014, a report has been received from Trial Court in respect of Respondent No. 10 stating therein that Respondent No. 10 is dead.

*** In SLP (C) No. 491/14, counsel for the petitioner has not filed any proof of service of SLP to Respondent Nos. 1 & 2. Hence, no Counter Affidavit has been filed.

**** In SLP (C) No. 3513/2014, Counsel for the petitioner has on 05.12.2014 filed an application for stay which is defective and Counsel has not cured the defects despite this Registry's letter dated 20.12.2014.

in SLP (C) No. 3511/2014, a report has been received from Trial Court stating therein that Respondent No. 41 is dead.

In SLP (C) No. 4711/2014, Ms. Sunita Sharma, Advocate has not cured the defects in the Vakalatnama /Memo of

Appearance and Counter Affidavit so far. Counsel for the petitioner has not filed application for substitution of deceased Respondent No. 9 so far.

SLP(C) Nos. 16336 AND 14035/2014

It is submitted that Counsel for the petitioner has not taken fresh steps. Therefore, fresh show cause notice could not be issued to the sole respondent.

Service of show cause notice is not complete on sole respondent.

SLP (C) No. 17267/2014

It is submitted that Counsel for the petitioner has not taken fresh steps for effecting service upon Respondent Nos. 1, 4 and 28-31. Hence, fresh show cause notice could not be issued to the said respondents.

Service of show cause notice is incomplete in respect of Respondent Nos. 1, 4 and 28-31.

SLP (C) No. 21459/2014

It is submitted that Counsel for the petitioners has not taken fresh steps. Hence, fresh show cause notice could not be issued to all the unserved respondents.

Service of show cause notice is incomplete.

SLP (C) No. 18544/2014

It is submitted that Mr. Tushar Bakshi, Advocate has filed Vakalatnama /Memo of Appearance and Counter Affidavit on behalf of sole respondent.

Service of show cause notice is complete.

In SLP(C)Nos. 9830, 9831, 9833, 9836, 9838, 9839 & 9839, 8324, 8386 of 2014, Counsel for the petitioners has not taken fresh steps to served unserved respondents so far.
