The matters above mentioned were listed before the Registrar's Court on 9<sup>th</sup> August, 2016, when the following order was passed:-

"C.A. No.7/2015

Parties have not filed statement of case despite expiry of the statutory period.

C.A. No.430-32/2015

Ld. Counsel for the appellant to take fresh steps to effect service on the sole respondent within two weeks time as last opportunity. Notice thereafter be issued.

C.A. No.429, 523 of 2015

Ready matters.

C.A. No.8916-17/2015

Respondent no.1 has already filed counter affidavit.  
Respondent no.2 is granted four weeks time as last opportunity for filing counter affidavit.

C.A. No.5722-23/2015

Respondent no.2 has already filed counter affidavit but he has mentioned on behalf of respondent no.1. As such, correction be made within two weeks time.

Ld. Counsel for the appellant to furnish fresh address of respondent no.1 within two weeks time. Notice thereafter be issued.

C.A.No.3131/2015

Sole respondent has already filed counter affidavit.  
List again on 19.10.2016."

C.A. NO. 7 OF 2015

It is submitted that Counsel for the Appellant has not filed Statement of Case but Counsel for the Respondent has filed Statement of Case despite Registry's notice dated 9<sup>th</sup> April, 2015, time to file Statement of Case has already expired.

**C.A. NO. 430-32 OF 2015**

It is submitted that Counsel for the Appellant has not taken any fresh steps so far.

**C.A. NOS. 429 AND 523 OF 2015**

It is submitted that the appeals above-mentioned are Ready vide Ld. Registrar's Court Order dated 9<sup>th</sup> August, 2016.

**C.A. NO. 3131 OF 2015**

It is submitted that Counsel for the Appellant and Respondent has not filed Statement of Case so far despite Registry's notice dated 1<sup>st</sup> June, 2015, time to file Statement of Case has already expired.

**C.A. NOS. 5722-23 OF 2015**
