OFFICE REPORT

The office report was listed before the Ld. Registrar Court on 26th April, 2016, when the following order was passed:-

“C.A. No. 429/2015

Sole respondent to file counter affidavit within four weeks.

C.A. No.430-432 /2015

Fresh steps to be taken for service of the sole respondent within two weeks. Notice thereafter be issued.

C.A. No. 7/2015

Sole respondent to file counter affidavit within four weeks.

C.A. No. 523/2015

Sole respondent to file counter affidavit within four weeks.

C.A. No. 3131/2015

Sole respondent has filed counter affidavit.

C.A. No. 5722-5723/2015

Respondent No. 1 has already filed the counter affidavit.

But vakalatnama has not been filed. The same be filed within two weeks.

Respondent No. 2 to file counter affidavit within four weeks.

The Ld. Counsel for the appellant is granted three weeks' time for filing deficit court fee.

C.A. No. 8916-8917/2015

Respondent No. 1 has already filed the counter affidavit.

Respondent No. 2 to file counter affidavit within four weeks.

List again on 9.8.2016.”

C.A. No. 7 OF 2015

It is submitted that counsel for the respondent has not filed counter affidavit so far but he has filed statement of case.

It is further submitted that counsel for the appellant has not filed statement of case so far despite Registry's notice dated 9th April 2015 time to file statement of case has already expired. The appeal is ready as per amended Supreme Court rules.

C.A. Nos. 430-432OF 2015

It is submitted that counsel for the appellant has not taken any fresh steps for effecting service of the sole respondent.

C.A. No. 429 OF 2015

It is submitted that counsel for the respondent has not filed counter affidavit so far.

It is further submitted that counsel for the appellant and counsel for the respondent have not filed statement of case so far despite Registry's notice dt. 24th April, 2015. Time to file statement of case has already been expired. The appeal is ready as per amended Supreme Court Rules.

C.A. No. 523 OF 2015

It is submitted that counsel for the respondent has not filed counter affidavit so far.

It is further submitted that counsel for the appellant and counsel for the respondent have not filed statement of case so far despite Registry's notice dt. 17th March, 2015. Time to file statement of case has already been expired. The appeal is ready as per amended Supreme Court Rules.

C.A. Nos. 8916-8917 OF 2015

It is submitted that Mr. M.P. Devanath, counsel for the respondent No. 2 has not filed counter affidavit so far.

C.A. Nos. 5722-5723 OF 2015

It is submitted that Mr. Pawanshree Agrawal, Advocate has also on 27th January, 2016 filed Counter Affidavit on behalf of respondent No. 2.

It is further submitted that unserved cover in respect of respondent no. 1 has been received back with the postal remark “insufficient address hence returned to sender”. Counsel for the appellant has not taken any fresh steps in respect of Respondent no. 1.

It is lastly submitted that counsel for the appellant has not filed deficit Court fee as per his undertaking mentioned at page No. 47 of the petition of appeal.

C.A. No. 3131 OF 2015

It is submitted that counsel for the appellant and counsel for the respondent have not filed statement of case so far despite this Registry notice dated 1st June, 2015. The appeal is ready as per amended Supreme Court Rules.
