C.A. Nos. 429, 430-432 AND 7 OF 2015

The matters above-mentioned were listed before the Hon'ble Court on 7th January, 2015, when the Court was pleased to pass the following order:-

Admit.
Tag with Civil Appeal No. 9725 of 2014.”**

C.A. No. 429 OF 2015

Accordingly, Notice of Lodgment of Petition of Appeal was issued to the sole respondent on 12th February, 2015, through registered A.D. Post. Mr. B.K. Prasad, Advocate has on 28th March, 2015, filed Vakalatnama/Appearance on behalf of the sole respondent but has not filed counter affidavit so far.

C.A. Nos. 430-432 OF 2015

Accordingly, Notice of Lodgment of Petition of Appeal was issued to the sole respondent on 12th February, 2015, through registered A.D. Post. Neither A.D. Card nor unserved cover containing the notice has been received back from the sole respondent so far.

C.A. No. 7 OF 2015
