We have heard learned counsel for the parties.

There is an inordinate delay of nearly 30 years in
challenging the Notification dated 1st March, 1989 issued
under Section 4 read with Section 17(4) of the Land
Acquisition Act, 1894. The High Court by the impugned
order dated 23rd February, 2021 has dismissed the Writ
Petition on some other ground. Keeping in mind the delay
and laches in approaching the High Court, we decline to
entertain the Special Leave Petition. It is accordingly
dismissed.
