O R D E R

1. After arguing for some time, the learned senior counsel, Mr. C.U. Singh for the appellants submits that one of the issues involved in the present set of Appeals, namely, the issue on the interpretation of the expression "the material resources of the community" as contained in Article 39(b) of the Constitution of India, has been referred to the Nine Judges Bench by the Seven Judges Bench in the case of "Property Owners' Association and Ors. Vs. State of Maharashtra and Others, (2013) 7 SCC 522", and it would be desirable to adjourn the Appeals till the decision by the Nine Judges' Bench.
2. The learned senior counsel, Mr. C.S. Vaidyanathan for the respondent - State also does not dispute the said position.
