The matter above mentioned was listed before the Hon'ble Court on 27th July, 2015 when the Court was pleased to pass the following order:

"There is a letter for adjournment circulated by learned counsel for respondent No.1.

List the matter after pleadings are complete."

It is submitted that there are six Respondents in the instant matter. Respondent No.1/State is represented by Mr. Adarsh Upadhyay, Advocate. Unserved covers containing the notice were received in respect of Respondent Nos. 2 & 4 having postal remarks "Not claimed, returned to sender" and in respect of Respondent No.6 "No such addressee".

No return of service has been received back from Respondent Nos. 3 & 5, so far.

It is submitted that pursuant to Registrar Court's Order dated 21st August, 2015, Counsel for the Petitioner has neither filed Affidavit of dasti service in respect of Respondent Nos. 3 & 5 nor filed fresh particulars of Respondent Nos.2, 4 & 6, so far.

Service of Show Cause Notice in respect of Respondent Nos. 2 to 6 is incomplete.

The matter above mentioned was listed before the Court of Registrar on 16th November, 2015 and lastly on 22nd January, 2016 when the following order was passed :

"The respondent No.1 has failed to file the counter affidavit within the period stipulated under the rules. Four weeks time as last chance is given to the Ld.counsel for the petitioner to comply with the terms of the order dated 16.11.2015 of this Court in respect of the respondent No.3 & 5.

Ld.counsel for the petitioner has failed to take fresh steps in respect of the respondent Nos. 2,4 & 6 in spite of last chance granted. Viewed in that context, the matter shall be processed for listing before the Hon'ble Judge in Chambers for further directions. Await orders and list thereafter. "

It is lastly submitted that Counsel for the Petitioner has neither filed Affidavit of dasti service in respect of Respondent Nos. 3 & 5 nor fresh particulars of Respondent Nos.2, 4 & 6, so far.

Accordingly, an office report for directions in the matter above mentioned is listed before the Hon'ble Judge in Chambers for orders.
