OFFICE REPORT

The matter above mentioned was listed before the
Ld. Registrar's Court on 21.09.2015, when the following
Order was passed:-

" The ld. Counsel for respondent no.1
has requested four weeks time to file
counter affidavit. Be filed as assured, as
last opportunity. Petitioner still to cure
the defects in the application for
substituting the legal representatives of
the deceased respondent no.2. The ld.
Counsel has undertaken to cure the same
within four weeks time. Be cured as assured.
Application thereafter be processed as per
rules.

An application for impleadment which
has already been directed to be taken at the
time of final hearing but the notice to the
proposed party has already been issued and
the service report is awaited.

List again on 10.12.2015."

It is submitted that Dr. (Mrs.) Vipin Gupta,
Counsel for Respondent No. 1 has again on 03.12.2015
filed Counter Affidavit on his behalf. However, she has
already filed Counter Affidavit on behalf of Respondent
No. 1 on 16.01.2015 and a letter dated 05.12.2015 to Dr.
(Mrs.) Vipin Gupta, Advocate has been issued on
05.12.2015 for clarification in this regard.

It is further submitted that Counsel for the petitioner has not cured the defects in the application for substitution of deceased Respondent No. 2 despite Ld. Registrar's Order dated 12.12.2014, 12.02.2015, 23.03.2015, 23.07.2015 and 21.09.2015 and this Registry's letter dated 01.04.2015.

It is further submitted that a notice for alternative arrangement for Advocate in the application for Impleadment (being I.A Nos. 9-10) has been issued to the applicant for impleadment whose erstwhile Advocate Mr. S.K. Sabharwal has expired. However, no service report of the notice for alternative arrangement has been received back so far.

Service of show cause notice is not complete in respect of Respondent No. 2 (Now deceased).

The matters above mentioned are listed before the Ld. Registrar's Court with this office report.
