Heard learned counsel for the parties.

While issuing notice in the special leave petition on 13.12.2013, this Court had directed the respondent-Nigam not to finalise the tenders pursuant to the Notice Inviting Tender dated 24.08.2011.

Today, a xerox copy of letter dated 22.01.2014 sent by the Rajasthan Rajya Vidyut Utpadan Nigam Ltd., Vidyut Bhawan, Janpath, Jyoti Nagar, Jaipur - 302005 to M/s Wonder Cement Ltd., Makrana Road, MadanGanj, Kishangarh, Distt.Ajmer - 305801 has been produced before us by the learned senior counsel for the petitioner and from the said letter, it appears to

us that fly ash generated from Kota Thermal Power Station, Kota on chargeable basis has been allocated to M/s Wonder Cement Ltd. Prima facie, it appears to us that the order dated 13.12.2013 passed by this Court directing the respondent-Nigam not to finalise the tenders pursuant to the Notice Inviting Tender dated 24.08.2011 has been violated.

Issue notice to the respondents/alleged contemnors.

The contemnor Nos.1 and 2 need not appear in person but contemnor Nos.3 and 4 are directed to appear in person in the Court on the next date of hearing.

List these matters on 10.03.2014.

In the meanwhile, there shall be no sale of fly ash without the leave of this Court.
