OFFICE REPORT

It is submitted that Mr. D.K Sharma, Advocate has filed Special Leave Petition on 19.3.2016 against the Judgment and Order dated 10.12.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 4073, 4075, 4076, 4078, 4079, 4084, 4086, 4088, 4089, 4272, 4273, 5179, 5183, 5185, 5186, 5188, 5189, 5190, 5193, 5745, 5750, 5753, 5758, 5759, 6182, 6185, 6187, 6410, 6411, 6834, 6835, 6836, 6837 of 2013 and 1, 3, 4, 9, 10, 204, 235, 378, 2744. 2747, 2782, 3383 of 2014 alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of

deceased petitioner namely Sukhpal in RFA No. 5745/2013 and Smt. Rewati in RFA No. 4/2014 which is barred by time by 271 and 780 days respectively and Counsel has also filed an application for condonation of delay in filing substitution application with prayer for setting aside abatement.

It is further submitted that Counsel for the petitioner has filed **two applications** for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 2, 4, 6, 7, 8 and 9 days respectively in filing the SLP (ii) a delay of 108 days in refiling the SLP. There is a total delay of 110, 112, 114, 115, 116 and 119 days in filing and refiling the SLP.

It is further submitted that SLP (C)CC No.14730-14761/2016 Entitled Chander Singh and Ors. Etc. Etc. Versus state of Haryana and Ors. Etc. Etc. arising out of common order is fresh adjourned matter.

It is further submitted that Counsel for the petitioner has not furnished the copies of order dated 18.2.2002 and exhibits and award dated 20.5.2013. In this regard, **counsel has given a letter dated 11.8.2016(Copy of letter enclosed at page 341)** stating therein that the same are not necessary and counsel has requested to place the matter at his own risk.

The matter is listed before the Hon'ble Court with this office report.
