**OFFICE REPORT**

**S.L.P. © Nos. 13183-13194 of 2014**

The matter above mentioned was listed before the Hon'ble Court on 7<sup>th</sup> May, 2014, when the Court was pleased to pass the following order:-

**“Delay condoned.  
Issue notice.  
Tag with SLP © 12298 of 2014.”**

Accordingly, show cause notice was issued to all the twelve respondents by registered A.D. Post. A.D. Cards duly signed have been received back from respondent Nos. 3, 6, 9, 10 & 11 but no one has filed Vakaltanama/Appearance on behalf of the said respondents so far. Mr. P. Ramesh, Advocate has filed Vakalatnama/Appearance on behalf of respondent No. 7 but has not filed counter affidavit so far. Neither A.D. Cards nor unserved cover containing the notice has been received back from respondent Nos. 1, 2, 4, 5, 8, & 12 so far.
