SLP(C) 21652, 21653 AND 21655 of 2014

It is submitted that Counsel for the petitioner has on 31st July, 2015, filed a letter stating therein that Dasti notice may be issued for effecting service on the sole respondent in these matters. Accordingly, Dasti Notice was handed over to the Counsel for the petitioner with a request to file Affidavit of Service alongwith Proof of Service and counsel for the petitioner has on 15th September, 2015, filed Affidavit of Service alongwith Proof of Service but no one has filed Vakalatnama/Appearance on behalf of the said sole respondent in these matters so far. Service of Show Cause Notice is complete in these matters.

SLP(C) 21654 of 2014

It is submitted that Counsel for the petitioner has on 31st July, 2015, filed a letter stating therein that Dasti Notice may be issued for effecting service on the sole respondent.
