PETITION FOR SPECIAL LEAVE TO CC APPEAL (C) NOS. 765, 4929, 5454, 7758, 7930, 7936, 7937, 7938, 7942, 7941, 7943, 7940, 7946, 7945, 7947, 7948, 7949, 7950, 9612, 10558, 10559, 10560, 10561, 11143, 11145 AND 11146 OF 2014

The matters above-mentioned were listed before the Hon'ble Court on 25th April, 2014 with office report, when the Court was pleased to pass the following order:-

**“List the matters on 26th August, 2014, for final disposal.
Counter affidavit may be filed within four weeks from today
Rejoinder affidavit, if any, may be filed within two weeks
thereafter.
In the meantime, service shall be completed in all the matters.”**

SLP (C) NO. 765, 7945 AND 7948 OF 2014

It is submitted that no one has filed vakalatnama/appearance on behalf of the sole respondent though served with the notice.
