O R D E R

1. Heard Mr. Korada Pramod Kumar, learned counsel appearing for the petitioner (wife).
2. The respondent has received notice but instead of entering his appearance, he has sent a letter to the Court's Registry indicating his willingness to try Mediation for resolution of the matrimonial dispute.
3. As can be seen from the un rebutted pleadings, the complaint filed by the petitioner under the Domestic Violence Act and her claim for maintenance are both pending before the Courts at Ballari, Karnataka. The petitioner is also taking care of the minor son and she is residing in her parental home at Ballari.
4. Having considered the above, we allow this transfer petition. The HMP No. 38 of 2023 titled "*Mr. Kanhaiya v. Mrs. Priyanka*", pending before the Court of Civil Judge, Senior Division, Gondia, Maharashtra is directed to be transferred to the Principal Civil Judge & JMFC, Ballari, Karnataka.
5. Records of the case would be immediately transferred to the transferee court.
6. The parties are directed to appear, either in person or through an authorized representative before the transferee court.

However, in case there is non-appearance, court notice would be issued to the defaulting party.

7. The learned Court before proceeding to adjudicate the matter should facilitate the parties to explore the possibility of settlement, through mediation. This is recorded as the respondent has expressed his willingness and the counsel for the petitioner also submits that Mediation can be tried before the Court at Ballari.

8. The transferee court would decide the matter expeditiously.

9. Pending application(s), if any, shall stand closed.
