**SLP(C) No. 21592/2013:-**

The matter above mentioned was listed before the Hon'ble Court on 22.07.2013, when the court was pleased to pass the following order:

**SLP(C) Nos. 29275 & 31763/2013:-**

The matters above mentioned were listed before the Hon'ble Court on 27.09.2013, when the court was pleased to pass the following order:

**"Issue notice.  
Tag with SLP(C)No.21592 of 2013."**

It is submitted that pursuant to aforesaid orders show-cause notice was issued to all the respondents in all the SLPs.

Service position of each matter is as under:-

**1. SLP(C) No. 21592/2013**

It is submitted that there are 12 respondent in this SLP. Respondent Nos. 1 & 2 are represented by Mr. P.I. Jose, Advocate and Counter Affidavit filed by him on behalf of Respondent No. 1 has been included in SLP paper books. M/s Corporate Law Group and Rameshwar Prashad Goyal, Advocates are representing Respondent Nos. 3 & 4 to 8 respectively but they have not filed counter affidavits so far. A.D. Cards duly signed by Respondent Nos. 9 & 11 have been received but

no one has entered appearance so far. Counsel for the petitioner has on 16.10.2015 filed affidavit with proof of dasti service duly served upon respondent Nos. 10 & 12 vide order dated 23.09.2015 Hon'ble Judge in chambers but no one has entered appearance so far.

It is further submitted that counsel for the petitioner has on 17.02.2016 filed rejoinder affidavit with the leave of the Hon'ble Court to the counter affidavit of Respondent No. 1 and the same has been included in SLP paper books.

### **2. SLP(C) No. 29275/2013**

It is submitted that there are 5 respondents in this SLP. Respondent Nos. 1, 2 and 5 are represented by Mr. P.I. Jose, and Dr. Kailash Chand Advocate respectively but they have not filed counter affidavit so far. A.D. card duly signed by Respondent No. 4 has been received but no one has entered appearance so far. Counsel for the petitioner has filed proof of service of supply of copy of pleadings upon standing. Counsel for the state of Assam - Respondent No. 3, but no one has entered appearance so far.

### **3. SLP(C) No. 31763/2013**

It is submitted that there are 8 respondents in this SLP. M/s. P.I. Jose and Corporate Law Group, Advocates have filed Vakalatnama on behalf of Respondent Nos 1, 2 and 3 respectively but both the counsel have not filed Counter Affidavit so far. A.D. cards duly signed by Respondent Nos. 5 to 8 have been received but no one has entered appearance so far. Name of Respondent No. 4 has been deleted vide order dated 01.12.2015 of Hon'ble Judge in Chambers. Accordingly Cause Title has been amended and included in SLP paper books.

Service is complete in all the SLPs.
