The office report further states that although by order dated 7.07.2014 of this Court, six weeks time as last chance was given to the respondent Nos.3 & 4-8 to file the counter affidavit, yet they have not done the needful so far. Therefore, no further opportunity is warranted to be given to them on that count taking into consideration the rule position.

Service of notice is complete on the respondent Nos. 2, 9 & 11, but no one has entered appearance on their behalf.

Three weeks time as last chance is given to the Ld.counsel for the petitioner to take fresh steps for the service of notice to the unserved respondent Nos. 10 & 12.

Ld.counsel for the respondent No.1 has stated that he adopts the counter affidavit filed by him in SLP(C) No.21592/13 in this matter also. This is taken on record.

Three weeks time as last chance is given to the Ld.counsel for the petitioners to take fresh steps for the service of notice to the unserved respondent Nos.2, 3 & 5.

What gets revealed from the perusal of the office report is that although two opportunities have already been given to the respondent Nos.1-3 to file the counter affidavit, yet they have not done the needful so far. Therefore, no further opportunity is warranted to be given to them on that count taking into consideration the rule position.

The office report further is that service of notice is complete on the respondent Nos. 5-8, but no one has entered appearance on their behalf.

Three weeks time as last chance is given to the Id.counsel for the petitioner to take fresh steps for the service of notice to the unserved respondent No.4.
