We have put to learned counsel for the applicants that scope in these petitions is limited in character i.e. whether the persons who are aggrieved by a legislation can sit on the road in the area which is known as Shaheen Bagh. There are many unfortunate incidents which have occurred after that and that is not the subject matter before us. We are however informed that the High Court is in seisin of the issue and it is for the High Court to take a view of that matter as it deems appropriate. We are not precluding any of the applicants seeking any of the remedy which they have in law.
