ORDER

A. K. PATNAIK, J.

We find that there is a mistake in our judgment dated April 3, 2014 in Criminal Appeal No.736 of 2014 and other Crl.A. No. 736 of 2014

connected matters.

2. In paragraph 28 of the judgment, we have passed orders and directions considering the broad facts of three different categories of cases before us. In sub- para (i) criminal appeals in which appellants claim that they are in possession of the secured asset under lease made prior to the mortgage but the Chief Metropolitan Magistrate, Mumbai, has passed orders under Section 14 of the SARFAESI Act for delivery of possession of the secured asset to the respective secured creditors, have been listed. From the said list, some of the criminal appeals which fall in the aforesaid category have been left out and they need to be added.

3. Accordingly, in sub- para (i) after Criminal Appeal arising out of S.L.P.(Crl.) No. No.7747 of 2012, following criminal appeals be added:

4. We also find that in sub- para (ii), Criminal appeal
arising out of SLP(Crl.) No. 7722 of 2012 has been
wrongly added and, therefore, the same is deleted.

will issue corrigendum in accordance with this order.
