C.A. No. 5071/2011:-

It is submitted that there is sole respondent in this appeal and is represented by Mr. Subhasish Mohanty, Advocate. Service of notice of lodgment of petition of appeal is complete on the sole respondent.

It is further submitted that counsel for the appellant has filed statement of case and the same has been included in appeal paper books.

SLP(C) No. 1492, 1493, 1494 & 1495/2014:-

It is submitted that pursuant to this Court's Order dated 13.01.2014, show cause notice to sole respondent in all the matters was issued on 28.01.2014 and 10.02.2014 by regd. A.D.
