**OFFICE REPORT**

**SLP (C) No. 1493/2014 and 1495/2014:**

It is submitted that as directed above, counsel for the petitioner has on 16.10.2014 filed spare copy of SLP but he has furnished the address of concerned District Court of Andhra Pradesh and Chattisgarh but the respondents reside in Delhi. He was requested to furnish the correct address of the concerned District Court but he has not done the needful so far.

Service is not complete.

**SLP (C) No. 1494/2014:**

It is submitted that fresh show cause notice to sole respondent on fresh address was issued on 16.10.2014 by regd. A.D. Neither A.D. card nor unserved cover has been received so far.

Service is not complete.

**SLP (C) No. 3459/2014:**

It is submitted that in respect of sole respondent neither A.D. card nor unserved cover has been received so far. Counsel for the petitioner has filed a letter requesting for dasti service.

Service is not complete.

**SLP (C) NO. 13297/2014:**

It is submitted that pursuant to Hon'ble Courts Order dated 08.05.2014, show cause notice to sole respondent was issued on 22.05.2014 by regd. A.D. A.D. card duly signed has been received but no one has entered appearance.

Service is complete.

**SLP(C) No. 13548/2014 13549/2014 and 13550/2014:**

It is submitted that pursuant to Hon'ble Courts Order dated 27.05.2014, show cause notice to sole respondent in each matter was issued on 30.05.2014 and 06.06.2014 by regd. A.D. Neither A.D. card nor unserved cover has been received so far.

Service is complete.

**SLP(C) No. 16266/2014:**

The matters above-mentioned were listed before the Court of Ld. Registrar on 26.08.2014 when the Court was pleased to pass the following order:-

It is submitted that as directed above, show cause notice to the sole respondent was issued on 18.07.2014 by regd. A.D. Unserved cover has been received with postal remarks "No person at this address".

**As and when the other connected matters are complete, orders would be passed.**

It is submitted that as directed above, fresh show cause notice to the sole respondent on fresh address supplied by

counsel for the petitioner was issued on 31.10.2014 by regd. A.D. Nothing has been received so far.

Service is not complete.

**SLP(C) No. 19223/2014:**

It is submitted that nothing has been received from sole respondent so far.

Service is not complete.

**SLP(C) No. 19227/2014:**

It is submitted that Ms. Sushma Suri, Advocate has on 17.10.2014 filed affidavit of service duly serving the show cause notice to sole respondent was issued, however, dasti order was not passed by Court. Nothing has been received from notice sent by usual mode to the sole respondent so far.

**SLP(C) No. 19229/2014 and 19231/2014:**

It is submitted that show cause notice to sole respondent in each matter could not be issued as counsel for the petitioner has not filed process fee and spare copy so far despite this Registry's letter dated 11.08.2014 and 05.09.2014.

Service is not complete.

**SLP(C) No. 19285/2014:**

It is submitted that show cause notice to the sole respondent was issued on 04.09.2014 by regd. A.D. Nothing has been received from sole respondent so far.

**SLP(C) No. 21988/2014:**

It is submitted that pursuant to this Court's order dated 25.08.2014, show cause notice to sole respondent was issued on 05.09.2014 by regd. A.D. Neither A.D. card nor unserved cover has been received so far. Counsel for the petitioner has filed affidavit alongwith proof of dasti service, but the said affidavit has not been taken on record as Hon'ble Court has not ordered dasti notice.

**SLP(C) No. 23027/2014:**

It is submitted that pursuant to Court's Order dated 19.08.2014 and Hon'ble Judge in Chambers Order dated

**C.A. No. 5924 and 5926/2014:**

It is submitted that there are sole respondent in these appeals. Service of notice of lodgment of petition of appeal is complete in both the appeals but no one has entered appearance on their behalf so far.
