Application for extension of time is allowed.

Mr. Atmaram Nadkarni, Sr. Adv. submits that a sum of ₹102,73,69,496.28/- would be deposited in respect of compensation of village Tumulia and ₹48,35,50,464.82/- would be deposited in respect of compensation of village Jhupurunga.

Learned counsel appearing for the applicant opposes the request and submits that a proper interpretation of the judgment of this Court would result in liability which is equivalent to more

than twice the amount. The applicant is directed to keep the amount in an interest bearing deposit, awaiting further orders of the Court.
