appearance on behalf of the said respondents has not filed vakalatnama and counter affidavit despite grant of last opportunity on 07.10.2025.

Respondent no. 5 has filed counter affidavit.

Opportunity of respondent no.4 to file counter affidavit has already been declined.

As per office report, ld. Counsel for the petitioner has not taken fresh steps in respect of respondent no.3 despite last opportunity having been granted. However, ld. Counsel, Ms Srishti appearing on behalf of Mr Sabarish Subramanian, Advocate-on-record seeks further time to file vakalatnama and counter affidavit. As already time to file vakalatnama and counter affidavit has been granted on 09.12.2025 but no counter affidavit has been filed yet, hence last opportunity is granted to file counter affidavit by 28.01.2026. If filed, be taken on record, else further opportunity would stand declined. Vakalatnama be filed as per rules.
