O R D E R

SLP(C) No. 2912-2915/2018

Respondent nos.1 to 3 in SLP(C) No.2912, 2914 and 2915 of 2018 and respondent nos. 1 to 4 in SLP(C) No.2913/2018 have filed counter affidavit.
