**UPON hearing the counsel the Court made the following
O R D E R**

- 1) During hearing, it is informed that after the judgment in *Prem Singh v. State of Uttar Pradesh and Others* (2019) 10 SCC 516, the State of Uttar Pradesh has brought U.P. Qualifying Service for Pension and Validation Act, 2021 (hereinafter referred to as '2021 Act' for short). The vires of the said 2021 Act is under challenge and the matter is pending before the Coordinate Bench of this Court for hearing.
- 2) Learned senior counsel for the petitioner submits that in addition to the said challenge, even the petitioners are entitled to the benefit of the judgment in *Prem Singh* (supra).
- 3) Be that as it may, in the facts, we deem it

appropriate to list these cases in the month of January, 2026.

4) In case judgment in the case in which the 2021 Act is under challenge, is delivered prior to January, 2026, the petitioners are at liberty to make a mention before the Court.
