OFFICE REPORT

The office report was listed before Ld. Registrar's Court on 4<sup>th</sup> April, 2016, when the following order was passed:-

“SLP(C)NO. 12274/2014

Fresh steps for service of respondent nos. 1 and 2 be taken within two weeks time and notice thereafter, be issued.

SLP(C)NO. 12275/2014

Fresh steps for service of sole respondent be taken within two weeks time and notice thereafter, be issued.

SLP(C)NO. 12277/2014

Fresh steps for service of respondent no. 17 be taken within two weeks time and notice thereafter, be issued.

Respondent nos. 1, 4, 5, 6, 8, 10 to 13 and 15 have already filed counter affidavit.

None appears for respondent nos. 2, 3, 7, 9, 14, 16, 18 and 19 despite due service.

SLP(C)NO. 17215/2014

None appears for all the three respondents despite due service.

SLP(C)NO. 18585/2014

Fresh steps for service of respondent no. 5 be taken within two weeks time and notice thereafter, be issued.

None appears for respondent no. 1 despite due service.

SLP(C)NO. 18590/2014

Fresh steps for service of respondent no. 1 be taken within two weeks time and notice thereafter, be issued.

Four weeks time as last opportunity is granted to respondent no. 2 for filing counter affidavit.

**SLP(C)NO. 18592/2014**

None appears for both the respondents despite due service.

**SLP(C)NO. 18595/2014**

None appears for respondent no. 1 despite due service.

Await service on respondent no. 2.

**SLP(C)NO. 19776/2014**

Sole respondent has already filed counter affidavit.

**SLP(C)NO. 20042/2014**

None appears for sole respondent despite due service.

**SLP(C)NO. 22916/2014**

None appears for respondent nos. 1,2,5,6,7,9,11,13,14,15 to 19, 21 to 4, 27,28,31,32,34,35,36,38,39,41,42,45,49,50,51,53,54 to 57,60,67 and 71 despite due service.

Fresh steps for service of respondent nos. 3, 4, 8, 10, 12, 20, 25, 26, 29, 30, 33, 37, 40, 43, 44, 46, 47, 48, 52, 58, 59, 61 to 65,68,69,70 be taken within two weeks time and notice thereafter, be issued.

List again on 19.7.2016.”

**SLP(C) No. 12274 of 2014**

It is submitted that counsel for the petitioner has not filed spare copies of SLP so far. Hence, fresh show cause notice could not be issued to unserved respondent Nos. 1 and 2.

**SLP(C) No. 12275 of 2014**

It is submitted that counsel for the petitioner has not filed spare copies of SLP so far. Hence, fresh show cause notice could not be issued to unserved sole respondent.

**SLP(C) NO. 12277 OF 2014**

It is submitted that counsel for the petitioner has not filed spare copies of SLP so far. Hence, fresh show cause notice could not be issued to unserved respondent No. 17.

It is further submitted that no one has filed vakalatnama/appearance on behalf of Respondent Nos. 2, 3, 7, 9, 14, 16, 18 and 19 though served with notice.

It is lastly submitted that Mr. P. Geroge Giri, Advocate has filed Vakalatnama/Appearance and counter affidavit on behalf of respondent Nos. 1, 4, 5, 6, 8, 10 to 13 and 15.

**SLP (C)No. 17215 of 2014**

It is submitted that A.D. Cards duly signed have been received back from all the three respondents but no one has filed Vakalatnama/Appearance on behalf of the said

respondents so far. Service of notice is complete.

**SLP(C) NOS.18585 of 2014**

It is submitted that counsel for the petitioner has not filed spare copies of SLP so far. Hence, fresh show cause notice could not be issued to unserved respondent No. 2.

It is further submitted that A.D. Card duly signed has been received back from respondent No. 1 but no one has Vakalatnama/Appearance on behalf of the said respondent No. 1 so far.

**SLP(C) NO.18590 OF 2014**

It is submitted that counsel for the petitioner has not filed spare copies of SLP so far. Hence, fresh show cause notice could not be issued to unserved respondent No. 1.

It is further submitted that Mr. M.T. George, Advocate has filed Vakalatnama/Appearance on behalf of R.No. 1 but has not filed counter affidavit so far.

**SLP(C) NO.18592 OF 2014**

It is submitted that A.D. Cards duly signed have been received back from both the respondents but no one has filed Vakalatnama/Appearance on behalf of said respondents so far.

**SLP(C) NO.18595 OF 2014**

It is submitted that fresh show cause notice was issued to unserved respondent No. 2 on 2<sup>nd</sup> March, 2016 by Regd. A.D. Post. Neither A.D. Card nor unserved cover containing the notice has been received back from the said respondent so far.

It is further submitted that A.D. Card duly signed has been received back from respondent No. 1 but no one has filed Vakalatnama/Appearance on behalf of the said respondent so far.

**SLP(C) NO.19776 OF 2014**

It is submitted that counsel for the sole respondent has on 15<sup>th</sup> February, 2016 filed counter affidavit.

**SLP(C) NO. 20042 OF 2014**

It is submitted that A.D. Card duly signed and stamped has been received back from the sole respondent but no one has filed Vakalatnama/Appearance on behalf of sole respondent so far.

**SLP(C) NO. 22916 OF 2014**

It is submitted that counsel for the petitioner has not filed spare copies of SLP. Hence, fresh show cause notice could not be issued to unserved respondent Nos. 3, 4, 8, 10,

12, 20, 25, 26, 29, 30, 33, 37, 40, 43, 44, 46, 47, 48, 52, 58, 59, 61 to 65, 68, 69 and 70.

It is further submitted that A.D. Cards duly signed have been received back from respondent Nos. 1, 2, 5, 6, 7, 9, 11, 13, 14, 15 to 19, 21 to 24, 27, 28, 31, 32, 34, 35, 36, 38, 39, 41, 42, 45, 49, 50, 51, 53, 54 to 57, 60, 66, 67 and 71 but no one has filed Vakalatnama/Appearance on behalf of said respondents so far.

**SLP(C) NO. 589 OF 2016**

The matter above-mentioned was listed before the Hon'ble Court on 8<sup>th</sup> January, 2016, when the Court was pleased to pass the following order:-

**“Delay condoned.  
Issue notice.  
Tag with SLP(C) No. 10162 of 2014.”**

It is submitted that show cause notice was issued to both the respondents on 8<sup>th</sup> February, 2016 by Regd. A.D. Post. Mr. E.M.S. Anam, Advocate has on 9<sup>th</sup> April, 2016 filed Vakalatnama/Appearance on behalf of respondent No. 1 but has not filed counter affidavit so far. A.D. Card duly signed has been received back from respondent No. 2 but no one has filed Vakalatnama/Appearance on behalf of respondent No. 2 so far.
