Nobody appears for all the three respondents, despite due service.

Await service of respondent No.2. Nobody appears for respondent No.1, despite due service.

SLP(C) No. 18590/2014

Await service of respondent No.1. Registry to submit report regarding the status of respondent No.2.

SLP(C) No. 18592/2014

Nobody appears for the respondents, despite due service.

SLP(C) No. 18595/2014

Two weeks' time, as last opportunity, is granted to the petitioner for filing spare copy of the petition for service of respondent No.2. Notice thereafter be issued.

Nobody appears for respondent No.1, despite due service.

SLP(C) No. 19776/2014

Opportunity for the sole respondent to file the counter affidavit has already been declined.

SLP(C) No. 20042/2014

Nobody appears for the sole respondent, despite due service.

SLP(C) No. 22916/2014

Await service of respondent Nos.3, 4, 8, 10, 12, 20, 25, 26, 29, 30, 33, 37, 40, 43, 44, 46, 47, 48, 52, 58, 59, 61 to 65, 68, 69 and 70.

Nobody appears for respondent Nos.1, 2, 5, 6, 7, 9, 11, 13, 14, 15 to 19, 21 to 24, 27, 28, 31, 32, 34, 35, 36, 38, 39, 41, 42, 45, 49, 50, 51, 53, 54 to 57, 60, 66, 67 and 71, despite due service.

SLP(C) No. 24966/2014

Four weeks' time, as last opportunity, is granted to the petitioner for filing application for substitution of the legal representatives of the deceased respondent Nos.26 and 28.

Nobody appears for respondent Nos.1 to 25, 27 and 29 to 37 despite due service.

SLP(C) No.12277/2014

Await service of respondent No.17.

Nobody appears for respondent Nos.2, 3, 7, 9, 14, 16, 18 and 19, despite due service.

Registry to submit report regarding the status of the remaining respondents.

SLP(C) No. 12274 of 2014

It is submitted that neither A.D. card nor unserved cover containing the notice has been received back from respondent Nos. 1 and 2 so far.

SLP(C) No. 12275 of 2014

It is submitted that neither A.D. card nor unserved cover containing the notice has been received back from the sole respondent so far.

SLP(C) NO. 12277 OF 2014

It is submitted that there are 19 respondents in this matter. Show cause notice was issued on 15th December, 2015 to unserved respondent no. 17. Neither A.D. card nor unserved cover containing the notice has been received back from the said respondent so far.

It is further submitted that no one has filed vakalatnama/appearance on behalf of Respondent Nos. 2, 3, 7, 9, 14, 16, 18 and 19 though served with notice.

SLP(C) NO.22916 OF 2014

Cards duly signed have been received back from respondent Nos. 1, 2, 5, 6, 7, 9, 11, 13, 14, 15 to 19, 21 to 24, 27, 28, 31, 32, 34, 35, 36, 38, 39, 41, 42, 45, 49, 50, 51, 53, 54 to 57, 60, 66, 67 and 71 but no one has filed Vakalatnama/Appearance on behalf of said respondents so far.

It is further submitted that Neither A.D. cards nor unserved cover containing the notice have been received back from from Respondent nos. 3, 4, 8, 10, 12, 20, 25, 26, 29, 30, 33, 37, 40, 43, 44, 46, 47, 48, 52, 58, 59, 61 to 65, 68, 69 and 70 so far.

SLP(C) NO.24966 OF 2014

It is submitted that there are 37 respondents in this matter. The counsel for the petitioner has not filed an application for substituting the legal representatives on record in respect of deceased respondent Nos. 26 and 28 so far.

It is further submitted that no one has filed Vakalatnama/Appearance on behalf of respondent Nos. 1 to 25, 27 and 29 to 37 though served with notice.
