ORDER

- 1 In the previous order dated 10 January 2022, this Court recorded the statement of Mr K M Nataraj, Additional Solicitor General, that a tabulated statement would be placed on the record indicating for each workman the precise amount which has been computed to be due under distinct heads and the total amount which is due and payable.
- 2 In pursuance of the above direction, a tabulated chart has been placed on the record.
- 3 We have heard Mr Haresh Raichura, counsel appearing on behalf of the petitioners and Mr K M Nataraj, Additional Solicitor General for the respondents.

- 4 The tabulated statement indicates that compliance has been effected. However, on the request of Mr Raichura, it is clarified that in the event that if any workman has died, in the meantime, the arrears due and payable under the original order would be paid over to the legal representatives, subject to the production of necessary verification.
- 5 The Contempt Petition is accordingly disposed of.
- 6 Pending application, if any, stands disposed of.
