**UPON hearing the counsel the Court made the following
O R D E R**

- 1 It has been agreed between the Attorney General and Solicitor General on the one side and Mr Kapil Sibal, Mr Dushyant Dave and Ms Indira Jaising, senior counsel appearing on behalf of the contesting parties that:
 - (i) Counsel shall jointly formulate the issues which would arise for decision in a joint conference between themselves; and
 - (ii) Counsel would segregate the cases which fall for decision into distinct categories and indicate the order in which the arguments would be addressed.
- 2 The Registrar (J-I) shall give a scanned copy of a complete set of the pleadings to Mr Fuzail Ahmad Ayyubi, counsel assisting Mr Kapil Sibal, senior counsel and Ms Diksha Rai, counsel assisting Mr R Venkataramani, Attorney General. They shall share the scanned copies with all the counsel.
