1. Delay condoned.
2. Leave granted.
3. We find that the main impugned judgment of the High Court dated 13.09.2022 already stands set aside by this Court vide judgment dated 21.10.2024, passed in C.A. No. 11758/2024 @ SLP(C)No.7963/2023 and connected matters [Hormal (Deceased) through his LRs. and others vs. State of Haryana and others].
4. Consequently, the appellant is also held entitled to the same amount of compensation as has been awarded to the other land owners vide the above-cited judgment, except that the appellant shall not be entitled to any interest for the delay period of 448 days in filing these appeals. Ordered accordingly.
5. The appeals stand allowed to the extent indicated above.
