O R D E R

In SLP(C)....CC NO.17790/2010

Having regard to the explanation submitted by affidavit dated 24.12.2010 in response to the directions contained in order dated 29.11.2010 and the reasons given in the application for impleadment, I.A. for impleadment/ amendment filed on 3.2.2011 is allowed as follows:

(i) Delay in filing the application for impleadment is condoned.

(ii) Instead of impleading the petitioners in the 24 writ petitions as respondents 2 to 25, as prayed, the respective writ petitioners should be shown as separate sets of respondent with separate SLP numbers and if any court fees becomes payable consequently, the petitioner should pay the same.

(iii) In other words, there will be single batch of 25 SLPs with 25 separate SLP numbers.

(iv) As a consequence, SLP(C).....CC.NO.17790/2010 shall be treated as a batch of SLPs where the order relating to the 25 writ petitions is challenged. Amended cause title to be filed.
