OFFICE REPORT

Fresh steps for the service of notice to the respondent No. 2 shall be taken by the learned counsel for the petitioner within a period of three weeks.

SLP(C) Nos. 14807-14812, 14825-14830/2013

Three weeks time, as last chance is given to the learned counsel for the petitioner to comply with the terms of the office report.

SLP(C) Nos. 20727,20823/2013

The learned counsel for the respondent shall file the counter affidavit within a period of four weeks, in case he intends to do so whereafter no further extension shall be provided.

SLP(C) Nos. 20740, 20748-20749/2013
