O R D E R

We have heard learned counsel for the parties.

This Transfer Petition has been filed by the petitioner-wife seeking transfer of H.M.A. No.599/2020 titled as "Manish Sinha vs. Renu Tiwari" pending before the Court of Principal Judge, Family Court, Karkardooma Courts, Delhi to the Competent Court of jurisdiction at the Family Court at Bareilly.

During the pendency of this transfer petition, the parties have entered into a compromise and an application has been filed by the learned

counsel for the petitioner praying therein to grant a decree of divorce in exercise of powers conferred under Article 142 of the Constitution of India in terms of the settlement agreement arrived at between the parties.

As per the terms of settlement, a demand draft of Rs.30,00,000/- has been handed over by the learned counsel for the respondent-husband to the learned counsel for the petitioner-wife in the Court today.

The parties have undertaken to withdraw all the cases filed against each other, as per the terms of settlement.

The parties henceforth, shall not have any claim against each other, whatsoever, in respect of the matrimonial dispute.

In view of the settlement reached between the parties, the marriage between the petitioner-wife and the respondent-husband shall stand dissolved by a decree of divorce with mutual consent in terms of the Settlement Agreement.

Let a decree of divorce be drawn accordingly and the Settlement Agreement shall be made a part of the decree.

With the aforesaid orders and directions, the transfer petition stands disposed of. Pending application(s), if any, shall also stand disposed of.
