O R D E R

W.P.(C) No. 43/2019

Service is complete on respondent Nos.1 to 3 but none has entered appearance.

Respondent Nos.4 and 5 have already filed counter affidavit.

W.P.(C) No. 99/2019

Four weeks' time is granted to respondent No.4 for filing counter affidavit.
