ORDER

1. This transfer petition has been filed by the petitioner-wife for transfer of HMA/1213/2023 titled as "*Deepak Agarwal Vs. Aroma Modi*" from the court of the Principal Judge, Family Court, North-East, Karkardooma Court, Delhi to the court of the Family Court, Patna, Bihar.
2. Heard learned counsel for the parties.
3. Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the Transfer Petition and direct that HMA/1213/2023 titled as "*Deepak Agarwal Vs. Aroma Modi*" be transferred from the court of the Principal Judge, Family Court, North-East, Karkardooma Court, Delhi to the court of the Family Court, Patna, Bihar.
4. The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.

5. After transfer of the petition, the transferee court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
6. The parties would be at liberty to participate in the proceedings before the Family Court through the video conferencing platform.
7. Pending applications, if any, stand disposed of.
