O R D E R

As per the office report, respondent no. 2 has been served. However, none has entered appearance on behalf of respondent no. 2. In the interest of justice, re-notify on 15<sup>th</sup> July, 2022.

Issue bailable warrants to respondent no. 2 in the sum of Rs. 20,000/- (Rupees Twenty Thousand Only) with one surety of the like amount to the satisfaction of the arresting officer for appearance of respondent no. 2 before this Court. The bailable warrants would be served through the SHO of the Police Station concerned who may contact the surety of the accused-respondent no. 2. It will be open to respondent no. 2 to appear through an advocate or approach the legal services committee for appointment of legal aid counsel.

Learned counsel for the petitioner states that the petitioner has received threats. The police will examine this aspect and take steps to ensure that no harm is caused and no threats are extended to the petitioner.
