OFFICE REPORT

It is submitted that Mr. Anis Ahmed Khan , Advocate has filed Special Leave Petition on 28.02.2015 against the Judgment and Order dated 11.12.2013 of the High Court of Punjab and Haryana at Chandigarh in RSA No. 179 of 1999 alongwith applications for permission to file Special Leave Petition and exemption from filing official translation.

It is further submitted that Counsel for petitioner has also filed an application for substitution of deceased petitioners namely Gurnam Singh and Shamsher

Singh which is barred by time by 1258 & 2398 days respectively and Counsel has also filed an application for condonation of delay in filing substitution applications.

It is further submitted that Counsel for the petitioner has filed two applications for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 354 days in filing the SLP (ii) a delay of 25 days in refiling the SLP. There is a total delay of 379 days in filing and refiling the SLP.

It is further submitted that leave in SLP (C)No. 10671 of 2014 Entitled Jaswinder Kaur & Ors Versus Parminder Singh & Ors arising out of common order was granted on 02.05.2014 by Hon'ble Court. The same is registered as CA No. 5550 of 2014 and is pending (Copy of order dated 02.05.2014 is enclosed herewith).

The matter is listed before the Hon'ble Court with this office report.
