OFFICE REPORT (IN DISPOSED OF MATTER)

The application for permission to file special leave petition above mentioned was listed before the Hon'ble Court on 6th April, 2015 when the Court inter-alia pass the following order:

"...Accordingly, we dismiss the application for permission to file the special leave petition with cost of Rs. One lakh to be deposited by the petitioner in the Registry of this Court within a period of four weeks, which is to be used for the cause juvenile justice."

It is submitted that Counsel for the Petitioner has not deposited the cost of Rs. 1,00,000/- in the Registry and 4 weeks time granted to deposit the amount has expired on 5th May, 2015.

The office report on default dated 11th May, 2015 was listed before the Hon'ble Court on 15th May, 2015 when the Hon'ble Court was pleased to pass the following order :

"Vide order dated 06.04.2015, learned counsel for the petitioner was directed to deposit an amount of Rs.1,00,000/- in the

Registry of this Court within four weeks. However, order dated 06.04.2015 has not been complied with.

In view of the above, the Registry is directed to take all the necessary steps under the relevant provisions of Supreme Court Rules, 2013 so as to recover the amount of Rs.1,00,000/- from the learned counsel for the petitioner and submit a report to this Court at the earliest. "

Pursuant to the order quoted above, a certified copy of Record of Proceedings dated 6th April, 2015 & 15th May, 2015 was forwarded to the Special Judge, P.C. Act, C.B.I.-7, New Delhi, District Patiala House Courts, New Delhi for taking necessary steps to recover the amount directed vide this Hon'ble Court's Order as above, as per Rule 6 Order XII of the Supreme Court Rules, 2013 but, response from the said Trial Court is awaited.

It is further submitted that Counsel for the Petitioner has on 18th May, 2015 filed an application for waiving of the cost of Rs.1,00,000/- imposed vide this Hon'ble Court's Order dated 6th April, 2015. The said application has been registered as Criminal Misc. Petition No. 10860 of 2015.

The application above-mentioned is listed before the Hon'ble Court for orders.
