**OFFICE REPORT**

**SLP(C) Nos. 12529, 12535, 12540, 12542, 12544, 12545, 12547 & 12549/2015:-**

The matters above mentioned were listed before the Registrar Court on 13.04.2016, when the Court was pleased to pass the following order:-

***"SLP(C) Nos. 12529, 12535, 12540, 12542, 12544, 12545, 12547 & 12549 /2015***

***Four weeks time as last chance is given to the respondent No.2 to file the counter affidavit in all the matters.***

***SLP(C) Nos.34747, 35270, 34743, 35268/2015 & 192/2016***

***The respondent No.2 in SLP(C) No.34747/15 is granted four weeks time to file the counter affidavit. Await the return of the service of notice already issued to the other respondents.***

***List the matters again on 12.07.2016.***

***SLP(C) Nos.23730-23731/2015***

***Service of notice is complete on the respondent No.1, but no one has entered appearance on his behalf. The respondent No.2 has already filed the counter affidavit. Viewed thus, the matters shall be processed for listing before the Hon'ble Court as per rules. SLP(C) No.23734/2015***

***Both the respondents have failed to file the counter affidavit within the period stipulated under the rules. Viewed thus, the matter shall be processed for listing before the Hon'ble Court as per rules."***

It is submitted that as directed above, Counsel appearing for respondent No. 2 has not filed counter affidavit in all the matters so far. Counsel appearing for respondent No. 1 has not filed counter affidavit in SLP(C) Nos. 12545/2015, 12547/2015 and 12549/2015 so far.

Service is complete in all the matters.

**SLP(C) Nos. 16234, 16235 and 16237/2015:-**

It is submitted that the matters above mentioned are under process for listing before Hon'ble Judge in Chambers.

**SLP(C) Nos. 34743, 34747, 35268, 35270/2015 & 192/2016:-**
