**OFFICE REPORT**

It is submitted for the information of the Hon'ble Court that the instant matter has been filed against the Judgment and Order dated 08.07.2011 of the High Court of Delhi at New Delhi in L.A. APP No. 1017 of 2010. The matter initially filed on 15.02.2016 was barred by time by 1593 days. The matter was found defective and returned to the counsel. He has on 11.04.2016 refiled the matter after curing the defects which is barred by time by 28 days (regd. as I.A. Nos. 1 & 2 respectively).
