SLP(C)Nos. 12529, 12535, 12540, 12542, 12544, 12545, 12547 &
12549/2015:-

The matters above mentioned were listed before the Hon'ble Judge in Chambers on 30.03.2016 when His Lordship was pleased to pass the following order:-
