UPON hearing the counsel the Court made the following
O R D E R

The petitioner is accused in a case bearing Crime No.386/2024 registered at Police Station-City Kotwali Balodabazar, District- Balodabazar, Chhattisgarh for the offences punishable under Sections 153-A, 505(1)(B), 505(1)(b), 505(1)(c), 109, 120(B), 147, 148, 149, 186, 356, 332, 333, 307, 435. 436, 341, 427 of the Indian Penal Code and Sections 3 and 4 of the Prevention of Damage to Public Property Act. The bail application of the petitioner was dismissed by the High Court. He had already undergone about 6 months in jail.

Heard learned senior counsel for the petitioner and the learned additional solicitor general for the respondent.

Considering the nature of the case and the period of incarceration of the petitioner, we are of the opinion that a case of bail is made out for the petitioner.

Accordingly, the petitioner is directed to be released on bail forthwith on the usual terms and conditions to be decided by the concerned Court.

The present petition shall stand disposed of in the above terms along with pending application(s), if any.
