UPON hearing the counsel the Court made the following
O R D E R

SLP(C) No.257/2010 & SLP(C) No.1843/2010

Pursuant to our order dated 11th August, 2015, the Municipal Commissioner of Greater Mumbai has passed an order dated 12th October, 2015.

The order was passed after hearing all parties concerned including Nova Nirman Nigam (Respondent No.7).

The conclusion of the Municipal Commissioner in the order dated 12th October, 2015 is that Building No.7, which is the building in question, can be regularized under the Development Control Regulations, 1991 as

applicable to the Municipal Corporation of Greater Mumbai.

Learned counsel for Nova Nirman Nigam says that he has some objections to the order passed by the Municipal Commissioner. He is at liberty to question the correctness of the order in an appropriate forum.

We make it clear that in view of the order passed by the Municipal Commissioner, we are not adjudicating upon any of the questions that have been raised in the special leave petitions, nor are we commenting on the correctness or otherwise of the impugned judgment and order dated 16 th

December, 2009. We leave the questions open for consideration in an appropriate case.

In view of the above, we dispose of these special leave petitions with liberty as aforesaid.

Pending applications are also disposed of.

SLP(C) No. 2219/2010

Learned counsel for the petitioner says that the penalty amount will be paid within a period of three months from today. We expect the petitioner to pay the penalty amount on or before 29th February, 2016.

In view of the above, nothing further survives in the special leave petition, which is accordingly disposed of.
