O R D E R

We find no reason to interfere with the impugned order(s).

The Special Leave Petitions are accordingly dismissed.

However, insofar as the two properties in which no appeal has been filed by the landlord/original land owner, being survey No.26/1 and 26/5, we are inclined to grant liberty to the petitioners to file review before the Karnataka High Court.

Taking into consideration the pendency of the petition, the petitioners are permitted to file such review application before the High Court within a period of four weeks, in which case, the question of limitation will not come in their way.

Liberty is also granted to the petitioners to challenge the impugned order, insofar as those two survey numbers in which permission to file review is granted are concerned, in case such review application, is rejected by the High Court.

Pending application, if any, stands disposed of.
