This petition is filed under Section 25 of the Code of Civil Procedure seeking transfer of Petition No. A-92/2020 titled "*Renjith Radhakrishna Nair vs. Sreeja Renjith Nair*" pending before the Family Court, Nasik, Maharashtra to the Family Court, Kollam, Kerala.

Having heard learned counsel appearing on behalf of both the parties and perusing the materials available on record, we are of the view that the transfer can be allowed. Consequently, the Transfer Petition is allowed.
