SLP(C) No. 22086/2023

1. The present petition arises out of a suit for partition wherein a preliminary decree was passed and was affirmed by the High Court.

2. The aforesaid preliminary decree was challenged by one of the parties by means of SLP(C) Nos.4048-4049 of 2021 which came to be dismissed on 15.11.2022.

3. Since this special leave petition is also directed against the same preliminary decree, we do not consider it to be a fit case for exercise of our power under Article 136 of the Constitution of India.

4. The present petition is, accordingly, dismissed.
