Heard the learned counsel appearing for the petitioner.

The impugned orders granting bail have been passed nearly three years back. Therefore, at this stage, no interference with the impugned orders is called for in exercise of our jurisdiction under Article 136 of the Constitution of India. We, however, make it clear that in the event it is found that the accused/respondents in the respective Special Leave Petitions have misused the liberty granted under the impugned orders or are not cooperating with the Trial Court for early disposal of the case, it will be always open for the petitioner or the first respondent/State to apply for cancellation of bail.

Subject to what is observed above, the Special Leave Petitions are dismissed.

Pending applications stand disposed of accordingly.
