UPON hearing the counsel the Court made the following
O R D E R

The present miscellaneous application has been filed by the petitioner/applicant seeking interim bail on the ground of his

medical illness. It reveals from the record that even for medical illness, this Court earlier under its order dated 22.10.2022 permitted the petitioner to file application before the Trial Court for seeking interim bail, if so advised.

After we have heard learned counsel for the parties and taking into consideration the medical reports of the petitioner and ailment with which he is suffering consider it appropriate to grant him interim bail for a period of one month under the supervision of the local police authorities to provide him the medical assistance wherever it is available within the jurisdiction of National Capital Region (NCR).

The petitioner is in custody in Central Jail No. 11, Mandoli, New Delhi. The Superintendent of Central Jail No. 11, Mandoli, New Delhi may comply the formalities.

With the aforesaid directions, the interlocutory application as well as miscellaneous application stands disposed of.
