ORDER

This transfer petition has been filed by the petitioner-wife under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of H.M.A. Petition No.430 of 2021, titled as "*Sh. Narender Goyal @ Monu Vs. Smt. Preeti Gupta*", pending in the Court of Judge, Family Courts, North Rohini Courts, Delhi to the Court of Principal Judge, Family Courts, Firozabad, Uttar Pradesh.
